I. Report of the Executive Committee - Ray Rouse

K. Report of the Finance Committee

Ms. Gwyn Wilson presented the Summary of Financial Reports which included the County and State Expenditures, Institutional Funds through August 31, 2002 and a Summary of Expenditures from Discretionary Funds. Upon a motion by Gwyn Wilson and seconded by Pat Burden, the Summary of Expenditures from Discretionary Funds (Attachment No. 4) of the Financial Report) in the amount of \$2,574.58 were approved unanimously.

3) Dr. Wilson discussed the attached 2003 Diversity Report. This report reflects the data for the full-time employees of the college effective September 1, 2002.

4) Dr. Wilson presented the attached Tech Prep Articulated Credit Agreement with Johnston County Schools. Upon a motion by Keith Stewart and seconded by Cleve Paul, this agreement was approved as submitted.

5) Dr. Wilson reviewed the attached Mission Statement. After discussion of the recommended changes, a motion was made by Tommy Jarrett and seconded by Al King to approve the revised WCC Mission Statement as presented.

6) Dr. Wilson then commented to the board on the efforts by the different areas of the college to contribute to the recent Day of Remembrance and Caring. Dr. Wilson commended Tara Humphries for her efforts in coordinating these efforts.

7) Dr. Wilson announced to the board that Mr. Carl Lawson from Duke University will make a presentation on High Performance Engineering and Design in Capital Construction on October 7 at 1:30 in the Boardroom. He invited and encouraged all members to attend.

8) Dr. Wilson announced to the board that the 2002 Dental Assisting Class had 100% passing rate on the Dental Assisting National Board Examination.
