**If legal separation documents are NOT available, you may submit any TWO of the following:**

1. Letter on business letterhead from a reputable third party who can confirm your marital separation in their professional capacity (ex. religious/spiritual leader, marriage counselor, attorney, employer, landlord, etc.)
2. If you are a member of the military (or a military dependent), submit a letter from the Family Services Office, Unit Chaplain, or Unit S-1 Personnel Office confirming their knowledge of your marital separation.
3. Legal documents showing child support obligations
4. Copy of your lease/rental/mortgage documents
5. Previous two months utility bills indicating separate households.
6. Letter from a social agency (ex. DSS) indicating their knowledge of your marital separation and confirming that you are considered separated for the purposes of their program.
7. Copy of your signed 2013 IRS Tax Return Transcript, available from [www.irs.gov](http://www.irs.gov). If you filed a joint return with your estranged spouse, provide an explanation from your paid tax preparer as to why you continue to file jointly.

I hereby certify that all information contained in this document, including supporting documentation, is true and complete to the best of my knowledge. I understand that if I am found to have knowingly or intentionally given false or fraudulent statements and/or documentation, my eligibility for federal and state aid may be further verified and corrected as required.
