
To qualify for this scholarship, you must meet the following criteria:

- 2. Be a U.S. citizen and a resident of NC under NCGS 116-143.1, and is eligible for in-state tuition.
- 3. Must demonstrate financial need. Completion of the Free Application for Federal Student Aid (FAFSA) is required.
- 4. Must maintain a 2.5 or higher grade point average on a 4.0 scale.
- 5. Must use scholarship to pay tuition and fees, books and supplies and transportation.
- 6. Agree to continue at the community college where enrolled at time of scholarship award for the duration of the scholarship, for four consecutive fall/spring semesters or upon completion of a diploma program. This scholarship is not transferable to another student or another school.
- 7. Must complete a Consent Form for the State Employee's Credit Union Foundation Two-Year Scholarship program. This will be sent if selected for the scholarship.
- 8. You may be asked to provide a photo that will not be returned to me.
