

The types of financial assistance available for the summer term are limited compared to the fall and spring terms. Funds offered by the state of North Carolina are not available during the summer term. The Federal Pell Grant may be offered to students who meet certain eligibility criteria.

2018 Summer aid is based on the results of the **2017-2018** FAFSA. *If you have not already done so, complete the 2017-2018 FAFSA online at www.fafsa.gov and submit any additional documentation requested by the Financial Aid Office to complete your financial aid file.

****IMPORTANT NOTICE FOR STUDENTS WHO ARE ON FINANCIAL AID WARNING/SUSPENSION/PROBATION****

- If you currently have an unsatisfactory SAP status and choose to register during the Priority/Open registration period of April 9 – 12, financial aid WILL NOT be available to charge tuition/fees to your account. **Therefore, if you choose to register during this period, you will be responsible for paying your tuition costs in full OR enrolling in a payment plan by 4:00 p.m. on May 14, 2018 to avoid having classes dropped for non-payment.**
- Summer financial aid will not be applied to your account until official grades for all spring classes have been posted, your academic progress reviewed, and your eligibility confirmed. If you are unable to pay your tuition expenses by May 14, 2018, you may wish to consider registering for classes on May 21, 2018.

IMPORTANT INFORMATION ABOUT SUMMER FINANCIAL AID

- To be eligible for financial aid, students must be accepted into an approved certificate, diploma, or associate degree program at WCC.
- Full-time status for the summer Pell Grant is 12 or more credit hours. Students enrolling in less than 12 credit hours may have their aid prorated accordingly. NOTE - With the implementation of the year-round Pell Grant, students will be required to enroll in a minimum of 6 credit hours to qualify for summer aid if the 2017-2018 Pell Grant entitlement has been used during fall and spring semesters.
- Under no circumstance may a student receive greater than 150% of his/her scheduled Pell Grant award during an academic year. ****If our office receives information that a student has exceeded the annual maximum because of aid received at another institution during the 2017-2018 academic year, the student will be required to return all, or a portion of the aid received from WCC.**
- As with fall and spring semesters, Pell Grant funds for summer are credited to student accounts based upon enrollment status at the 10% point of the semester. Financial aid funds cannot be used to pay for No-Shows (NA), Audits (AU), or Test Outs/Credit by Exam (X). Financial aid for students reported as having received one of the above statuses will be reduced or eliminated accordingly and the student will be responsible for any outstanding charges on his/her account.
- If it becomes necessary to change the class schedule after registering for the summer term, all adjustments must be made by **officially** dropping or withdrawing from the course(s) by the dates posted in the Summer Schedule of Courses. **Financial aid recipients should consult with a Financial Aid representative to determine how schedule adjustments may affect the financial aid award.**
- Financial aid funds will not pay for classes that are not required to complete a student's program. Financial aid will be reduced or eliminated if it is determined that a student is enrolled in classes that fall outside of the approved major.

Tuition/Fees: Credit to Account or Refund

- If a student completely withdraws from all classes prior to the 60 percent point of the semester or term, the student may no longer be eligible for the full amount of Title IV funds as originally scheduled to receive for the period of enrollment. The student may owe all or a portion of all applicable tuition, fees and book charges to the College or the U.S. Department of Education. This indebtedness is known as a financial aid overpayment. Failure to repay a student financial aid overpayment may result in a hold being placed on the account. This hold prohibits registration for future classes and from obtaining an official College transcript.
- If anticipated financial aid is **NOT** awarded, the student will be responsible for any balance due on his/her account.
- Eligibility to receive a summer Pell Grant is based upon the availability of funds for the 2017-2018 academic year, enrollment status, SAP status, any indebtedness to the college, and class attendance.
- All correspondence to students regarding summer financial aid award offers will be sent to the address on file with the Office of Admissions and Records. ****Students are responsible for ensuring that the Office of Admissions and Records has the correct information on file. A "Request for Change of Information" form may be completed to update name and/or address changes.**
- Students who are **NOT** eligible for the summer Pell Grant should plan to pay any outstanding balance to the Cashier's Office by 4:00 p.m. on May 14, 2018 (*May 21, 2018 for late registrations*). **Failure to pay outstanding balances by the due date will result in the cancellation of all registered classes.**

If you do not understand any of the above listed policies and procedures, it is your responsibility to ask for clarification from a Financial Aid representative. Financial Aid Specialists are available without appointment Monday through Thursday from 7:45 a.m. until 5:30 p.m. and Friday from 8:00 a.m. until 1:00 p.m. The Financial Aid office also has extended hours every Tuesday until 6:00 p.m.
